## **Terms and Conditions**

By entering into this contract made on \_\_\_\_\_, 2026 by and between Oxbow Equine Services LLC, hereinafter called "Oxbow", and \_\_\_\_\_, the donor mare owner/agent agrees to the following for the breeding season of 2026:

**1.Fees:** The Donor Mare's Owner agree to pay fees as follows:

**1.1 Recipient Mare Sync Fee NON- REFUNDABLE (\$1250).** It secures one or more recipient mare(s) for the donor mare whose name appears above. Recipient mares will be selected for the donor mare based on the reproductive soundness and synchronization with the donor mare. Included in this fee: (a) all medications and treatments necessary (NOT including progesterone) for the recipient mare up until 35 days of pregnancy; (b) recipient board until 35 days of gestation. This fee applies for one (1) donor mare and allows up to three (3) in foal recipient mares for the 2025 breeding season.

**1.2 Fresh embryos from OPU/aspiration process:** Oxbow guarantees by this contract the implementation of ONE (1) fresh embryo resulting from Ovum Pick-Up (OPU)/aspiration process. If Oxbow has multiple recipient mares available to use at the time of transfer, we may be able to use the additional mares for the remaining embryos.

**1.3 The Embryo Transfer Fee (\$650):** includes the transfer of each embryo to a recipient mare and ultrasound pregnancy examinations.

**1.4 The Recipient Mare Pregnancy Fee (\$3500):** this fee will be due at 35 days of gestation for each pregnant recipient mare and should be paid by the donor mare owner/agent account.

**1.5 All charges associated with shipment of the embryo to Oxbow:** including express mail, airline shipping charges, courier service charges and returned freight charges. It is not Oxbow's responsibility to arrange flights or locate missing shipments.

**1.6 Injectable Progesterone Fee (\$42):** will be administered for the recipient mare to help maintain pregnancy. Recipient mare(s) MUST stay on Progesterone, up to 120 days of pregnancy.

**1.7 Recipient Mare Boarding Fee (\$15/day):** boarding fees will be charged starting on day 35 of the pregnancy check date at the rate of \$15.00 per day and continuing each day thereafter for the entire period the recipient mare remains at Oxbow.

**2. Donor Mare Owner is responsible for the transporting of the recipient mare(s) from Oxbow.** It is specifically understood and agreed between the parties prior to transporting of the recipient mare (s), all costs for services rendered in the contract shall be paid in FULL at that time. No recipient mare(s) shall be released without payment in full. Sufficient notice must be received by Oxbow to release any recipient mares in order to ensure the proper paperwork is prepared for shipment.

**2.1:** This Agreement is entered into Payette County, Idaho and shall be performed at least in substantial part in Payette County. The substantive laws of Idaho, regardless of any choice of law provisions or caselaw, shall govern the enforcement and interpretation of this Agreement. Any dispute shall be adjudicated in Payette County, Idaho. The donor mare owner/agent agrees to pay Oxbow Equine Services LLC all of their attorney's fees and costs to enforce this agreement including collecting any outstanding balance.

**3.** The recipient mare(s) must be **returned in good health and physical condition** to Oxbow at the Donor Mare Owner's expense once the recipient mare has weaned the foal. If the recipient mare(s) is returned unhealthy and/or injured, a fee of \$1000 per mare will be payable to Oxbow. If the recipient mare(s) die while under the care of the Donor Mare Owner, a fee of \$6000 per mare will be payable to Oxbow. If the recipient mare is not returned to Oxbow **by February 1st, 2028**, for any reason (other than death), the Donor Mare Owner will be charged \$6000 per mare.

**4. The recipient mare(s) is the property of Oxbow.** The Donor Mare Owner is strictly leasing the mare for her surrogate services. Therefore, it is unlawful for anyone to sell, trade, or relinquish the recipient mare without previously contacting Oxbow.

**5.** Oxbow makes no guarantees, warranties, or representations as to the success or outcome of the embryo transfer procedures herein completed.

**6.** Donor Mare Owner agrees to not to hold Oxbow liable for any disease, accident, death, among others, of Donor Mare's pregnant recipient, nor in-utero foal. Any insurance desired on the pregnant recipient, and/or in-utero foal is the sole responsibility of the Donor Mare Owner. Oxbow will exercise its best judgment in supervising all horses' care while at Oxbow.

**7. Oxbow breeding season will end on July 15th, 2026, or at our discretion on the quality of recipients available.**

**8. Our recipient mares are NOT for sale.**

**9.** The contractor whose name is mentioned above **CAN NOT sell or transfer this contract** to another person under any circumstances.

**10. Frozen Embryos:** Beginning on the date embryo arrives and entered the computer management program, the \$25.00 (twenty-five dollars) storage fee will be applied per embryo received from that date forward. **Billing will occur monthly for frozen embryo storage.**

**10.1** Oxbow Equine Service reserves the right to adjust prices accordingly as material costs increase or storage procedure changes. Owner will be notified of price increases.

**10.2 Insurance:** Client acknowledges that Oxbow Equine Service does not have insurance coverage for stored embryos. If desirable, the client is responsible for procuring insurance coverage against any damage.

**10.3 No Liability for Natural Disasters:** Service Provider shall not be liable for any loss or damage to stored embryos, including natural disasters.
